**The Draft Environmental Impact Report (DEIR) (SCH #2023020144) for the Sonoma County Comprehensive Cannabis Program Update (Cannabis Program Update) is now available for review**

Sonoma County (County) is the Lead Agency for the preparation and review of the Draft EIR for the **Sonoma County Comprehensive Cannabis Program Update (Cannabis Program Update)**. The Proposed Ordinance will apply to the unincorporated area of the County, except for the coastal zone. The County proposes to amend the County General Plan and County Code to continue to regulate and expand the types of allowed cannabis activities in the unincorporated area of the County. The County is considering regulatory requirements that would regulate cannabis activities through land use, zoning, operational requirements, and development standards.

Adoption of the proposed Cannabis Program Update will require the following actions by the County:

- Certification of the Final EIR (FEIR) for the Cannabis Program Update.
- Repeal of the existing Cannabis Ordinance: Article 88 (Sec. 26-88-250 through Sec. 26-88-258) of the existing County Code.
- Adoption of the proposed General Plan Amendments that consist of reclassification of cannabis to “controlled agriculture” to expand cannabis uses on agricultural lands, and adoption of policies that would limit the area of permanent structures on agricultural land and separate cannabis production on agricultural lands from existing residential areas to protect public health and safety.
- Adoption of proposed changes to Chapter 4, Article IX to add a cannabis business license and Chapter 26, Articles 18, 20, 22, 26, and 86 of the existing County Code to add new zoning standards

for cannabis uses. The zoning amendments would allow supply chain uses by-right (no planning permit required), including retail (dispensaries), lounges, distribution, testing labs, manufacturing, and processing, and would allow for larger cannabis grows in agricultural and resource zones with accessory uses such as events, retail, processing, and manufacturing.

- Adoption of refinements of the Sonoma County Uniform Rules for Agricultural Preserves and Farmland Security Zones to include cannabis as a qualifying prime agricultural use.

The County has prepared a Draft EIR pursuant to the California Environmental Quality Act (CEQA). A Final EIR (Response to Comments) will be prepared following public review and comment. The County will consider this information when deliberating adoption of the Cannabis Program Update. Following certification of the Final EIR and adoption of the Cannabis Program Update, subsequent proposed cannabis projects may rely on the EIR for CEQA compliance and/or tiering.

**Potential Environmental Effects:** The Draft EIR analyzes impacts in the areas of Aesthetics, Agriculture and Forestry Resources, Air Quality, Biological Resources, Cultural Resources, Energy, Geology and Soils, Greenhouse Gas Emissions and Climate Change, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise, Public Services and Recreation, Transportation, Tribal Cultural Resources, Utilities and Service Systems, Wildfire, Cumulative Impacts, and Other CEQA-Required Analysis. Significant and unavoidable impacts are identified in the following environmental issues areas:

#### **Air Quality**

- Expose a Substantial Number of People to Odors Considered Objectionable
- Contribution to Cumulative Impacts on Operational Criteria Air Pollutants

#### **Greenhouse Gas Emissions and Climate Change**

- Conflict with an Applicable Plan, Policy, or Regulation Adopted for the Purpose of Reducing the Emissions of Greenhouse Gases
- Contribution to Cumulative Impacts on Greenhouse Gas Emissions and Climate Change Impacts

#### **Noise and Vibration**

- Result in Excessive Short-Term Construction Noise Impacts

#### **Transportation**

- Conflict or Be Inconsistent with CEQA Guidelines Section 15064.3(b) Regarding Vehicle Miles Traveled (VMT)
- Contribution to Cumulative Impacts on Vehicle Miles Traveled

#### **Utilities and Service Systems**

- Contribution to Cumulative Impacts on Water Supply Sufficiency

In compliance with CEQA Guidelines Section 15087(c)(6), the lists specified under Government Code Section 65962.5 related to hazardous waste conditions include a total of 56 open leaking underground storage tanks, 96 open cleanup programs, and one military cleanup site listed in the county.
